NOSTALGIA CORNER

The December 1969 issue of the Douglaston Knight Light listed all the Committee Chairmen for the 1969-1970 Pythian Year. The Chancellor Commander was Hal Zakow. I recognized the names of five Chairmen who are still members of the Lodge. Three of them are Dr. Danny Klein, Seymour Resnick and Fred Scheinfeld. What is more amazing is that 42 years later, two of the Chairmen today are officers of North Shore Lodge and are still devoting so much time and energy to the Knights of Pythias. In 1969 Irv Kleiman was Chairman of Charity Aids and Jerry Geier was co-Chairman of the Spring Folic.

Before he wrote his column, "It Seems to Me," Ike Roffman wrote "Guess Who?" and "Guess What?" articles for the Bulletin. He stopped for a while and then started up again. The following article appeared in the January 1970 Knight Light:
